



## **WELFARE OF ANIMALS IN TRANSIT TESTS (WAIT)**

This is the new regulation for people who are transporting stock on journeys of over 65km, and under 8 hours .

Farming Connect was re-launched in summer of 2008.

**Funding is available again for training AND NOW AT 80%**

Ring FC ON 08456000813 TO REGISTER OR RE-REGISTER if you were in FC1

They will check eligibility, and will need your Holding Number and CRN.

### **IF YOU NEED TRAINING ASK FOR PRE APPROVAL FORMS NOW!**

Once registered you can ring 01267 225300 –Welsh assembly or Lantra 01982 552646 are dealing with funding.

They will send the form, you **return it** to them **BEFORE THE COURSE**, they will send you claim form for **80%** after the course.

### **Cost before funding**

TEST ONLY= £75 plus vat just ring for time if test only per person

Training and TEST = £110 plus vat per person

### **How it works**

When you register with us we need:

- Your name
- Your date of birth
- Your place of birth
- We can inform you of next scheduled dates, or if you are a group, we can arrange a date here to suit you as a group.
- We can also arrange to come to your venue if you have a minimum of 6 .

## Lantra awards paper based test

When you book your test, the paper will be generated for all these species

- **CATTLE**
- **SHEEP**
- **PIGS**
- **GOATS**
- **HORSES**

You can of course take just what you need, but we recommend that on day, have a bash at all the sections- you never know!

### **Do you need horses?**

Remember if you or your children ride for leisure/ pleasure, even if you are winning prize money at shows, you **may** not require it. The "Economic activity" rule would be more applicable to racehorse trainers, or equine professionals.

BUT, with Lantra awards system you can take horses at no extra charge, so it makes sense to do it then and there with your cattle and sheep questions.

- The test is a set of MULTIPLE CHOICE questions, so 4 potential answers are given to you, you have to choose the right one!
- 25 questions on short journeys, with 5 additional questions on sheep, 5 cattle etc. need 18 out of 25 correct on general section FIRST. Need 4 out of 5 correct to pass cattle, 4 out of 5 for sheep etc, which can be quite challenging.
- Logistically far better for large groups, and easy to do at your sites, we need seats a metre apart, but we have to send 2 people, one of whom can train, and the other invigilates the test-exam conditions, so no books, notes etc!
- No extra charges for Horses, pigs, goats, so often suggest you do them anyway!! You can choose that option on the day. Value added, and you never know when you might diversify into other species!!
- No flexibility for someone to just turn up on the day, you still have to be pre-registered and individual papers are generated to your name, which you have to sign.
- Results known to us after 10 days, they are marked at Lantra awards, we send them registered post. Your individual results will be communicated to each individual direct, not to the group as a whole.
- No photos required- No skillcards issued as in NPTC computer test
